Why the Change?



The California Voter's Choice Act is a new law passed in 2016 to modernize elections in California by allowing counties to conduct elections under a new model that provides greater flexibility and convenience for voters.

This new election model allows voters to choose when, where, and how to cast their ballot by:

- Expanding in-person early voting options
- Allowing voters to cast a ballot at any Vote Center within their county

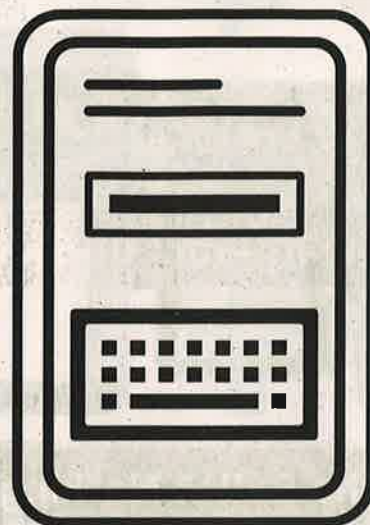
How to vote for a person not listed on the ballot

On the Ballot Marking Device:

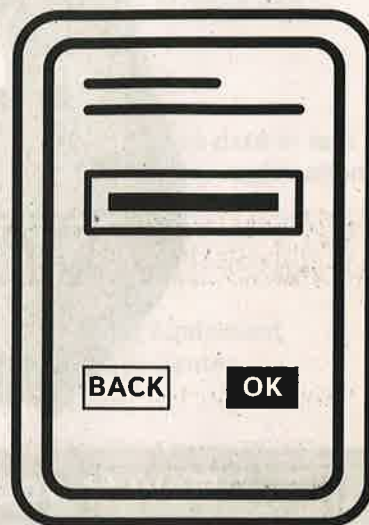
1. Select the "Write-in" option



2. Enter the candidate's name



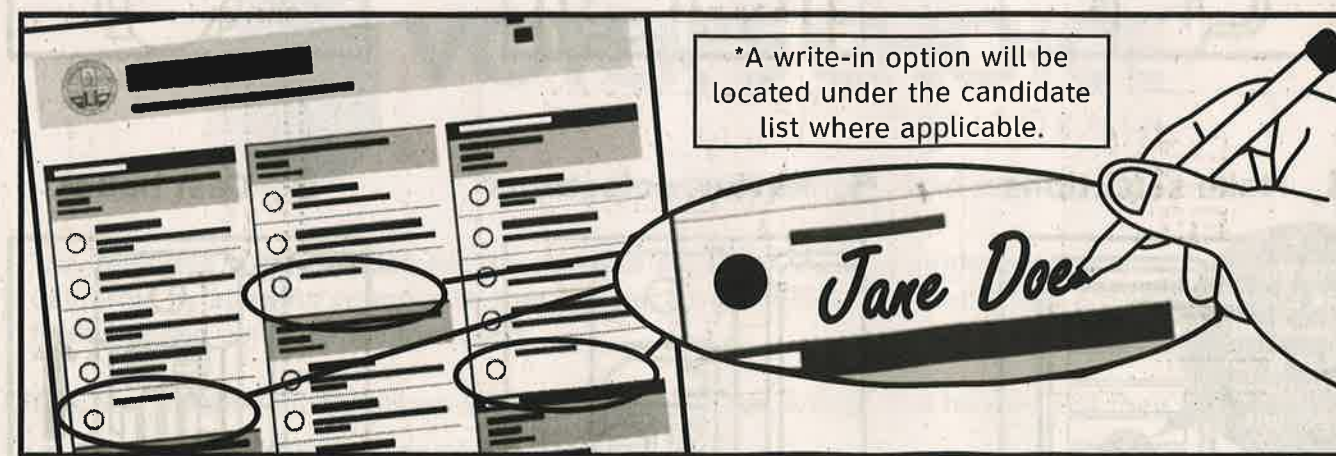
3. Review and confirm



On the Vote by Mail Ballot:

Write the name and office of the official write-in candidate in the "Write-in" portion of the ballot. A list of "Qualified Write-in Candidates" is available eleven days before the election at LAVote.net.

You may not write in a candidate and vote for a candidate on the ballot for the same office.



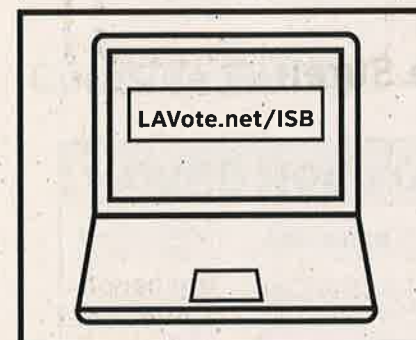
Interactive Sample Ballot



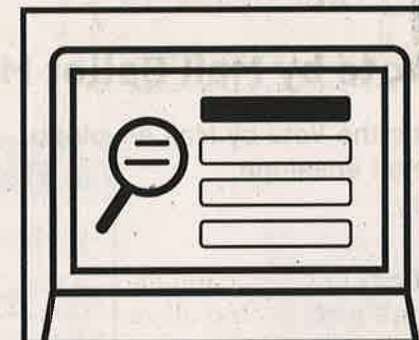
The **Interactive Sample Ballot (ISB)** is a convenient and optional application to speed up the voting experience. Voters can review and mark their selections on a computer or mobile device. Once the voter reviews and confirms their selections, the ISB will generate a Poll Pass. The Poll Pass is then taken to the Vote Center, where the voter will scan their Poll Pass to transfer their selections on to the Ballot Marking Device.

Additional Voting Options

Vote Early at Registrar-Recorder/County Clerk's Headquarters

Beginning February 3, any voter that would like to vote before the voting period (February 22 - March 3) can visit the Registrar-Recorder/County Clerk's Headquarters located at 12400 Imperial Highway in Norwalk to request and cast a ballot.

Beginning February 22, any voter may visit any Vote Center throughout Los Angeles County and cast their ballot.

Vote by Mail Ballot Drop-off

The Registrar-Recorder/County Clerk is providing Vote by Mail drop-off locations for the March 3, 2020 Presidential Primary Election.

Beginning February 3, any voter may drop off their voted ballot at any one of many convenient drop-off locations throughout Los Angeles County.

3. Remember no postage is necessary.

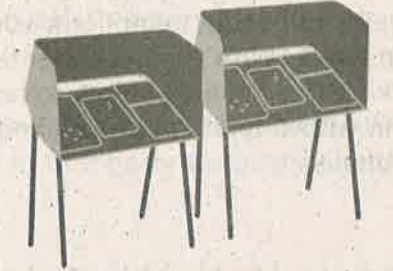

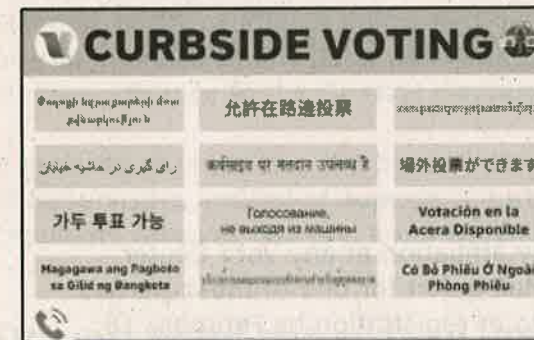
Accessible Vote by Mail

Information for Voters

Alternate Ballot Order (Senate Bill 25)

Senate Bill 25 was approved by the Governor on September 29, 2018 requiring the County of Los Angeles to conduct elections using an alternate ballot order for three years once the voting system is updated. With the implementation of Voting Solutions for All People (VSAP), our new Ballot Marking Device will be able to accommodate the changes in the ballot. The new ballot order will begin with City/Local offices and measures and will end with the President and Vice President nominees.

Crossover Voting for No Party Preference Voters

If you registered to vote without stating a political party preference, you are a No Party Preference (NPP) voter. For presidential primary elections, each political party has the option to allow NPP voters to request their party's presidential ballot. The following parties will allow NPP voters to request their party's presidential ballot:

- American Independent
- Democratic
- Libertarian

NPP voters can request a crossover at any Vote Center. To request a Vote by Mail ballot, voters can fill out and return the application on the back cover of this booklet, or complete the online application at LAVote.net.

The following parties do not allow NPP voters to request their party's presidential ballot:

- Green
- Peace and Freedom
- Republican

NPP voters can receive a party's ballot by changing their party affiliation at any Vote Center through Conditional Voter Registration. To receive a Vote by Mail ballot for one of these parties you must change your party affiliation by completing a new voter registration by February 18.

Offices on the Ballot

The ballot for this election includes both partisan and non-partisan nominating offices. Your ballot may also include local nonpartisan contests (County Board of Supervisors, County District Attorney, Superior Court Judges, School or Special Districts, and/or City offices).



Information for Voters

Party-Nominated Offices

If you indicated a political party preference when you registered to vote, you may only vote for party-nominated partisan offices for that particular party in the Presidential Primary Election.

The United States Presidential candidate is nominated by members of his or her political party through presidential primary elections. However, a political party may allow a voter who has declined to disclose a party preference (No Party Preference) to vote in that party's primary election.

Voter-Nominated Offices

All voters may vote for any candidate for a voter-nominated office. The "Top Two" candidates at the Primary Election advance to the General Election.

The following voter-nominated offices for this election are: U.S. Congressional, State Senator and State Assembly.

A Write-in candidate will only move on to the General Election if the candidate is one of the "Top Two" candidates in the Primary Election.

Nonpartisan Offices

Political parties are not entitled to nominate candidates for nonpartisan offices at the Primary Election, and a candidate nominated for a nonpartisan office at the Primary Election is not the official nominee of any party at the ensuing General Election. The top two candidates at the Primary Election advance to the General Election for the nonpartisan office.

A majority of votes cast (50 percent plus 1 vote) is required to elect a candidate for County Board of Supervisors, Judges of Superior Court, County District Attorney, City Council, or City Mayor. If no candidate receives 50% +1, a run-off will occur.

Do you need assistance voting?

If a voter declares under oath that they are unable to mark a ballot that voter may receive assistance marking their ballot by two (2) persons of their selection. (E.C. 14282)

Voter Bill of Rights

You have the following rights:

1. **The right to vote if you are a registered voter.** You are eligible to vote if you are:

- a U.S. citizen living in California
- at least 18 years old
- registered where you currently live
- not currently in state or federal prison or on parole for the conviction of a felony
- not currently found mentally incompetent to vote by a court

2. **The right to vote if you are a registered voter even if your name is not on the list.**

You will vote using a provisional ballot. Your vote will be counted if elections officials determine that you are eligible to vote.

3. **The right to vote if you are still in line when the polls close.**

4. **The right to cast a secret ballot** without anyone bothering you or telling you how to vote.

5. **The right to get a new ballot if you have made a mistake,** if you have not already cast your ballot. You can:

Ask an elections official at a Vote Center for a new ballot,

Exchange your vote-by-mail ballot for a new one at an elections office, or at your Vote Center, or **Vote using a provisional ballot.**

6. **The right to get help casting your ballot** from anyone you choose, except from your employer or union representative.

7. **The right to drop off your completed vote-by-mail ballot at any Vote Center** in California.

8. **The right to get election materials in a language other than English** if enough people in your voting precinct speak that language.

9. **The right to ask questions to elections officials about election procedures** and watch the election process. If the person you ask cannot answer your questions, they must send you to the right person for an answer. If you are disruptive, they can stop answering you.

10. **The right to report any illegal or fraudulent election activity** to an elections official or the Secretary of State's office.

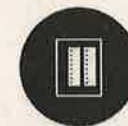

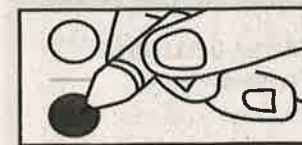

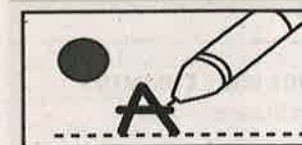

- You don't have to vote in every race.

Write-In Candidates



- A voter is entitled to cast a vote for a qualified write-in candidate for any party-nominated, voter-nominated or nonpartisan office by writing, on the write-in portion of the ballot, the name of the qualified candidate.
- To add a candidate, fill in the circle to the left of "Write-in Candidate" and write the name on the dotted line.
- A list of qualified write-in candidates is available eleven days before the election at lavote.net.
- Do not write-in a candidate whose name already appears on the ballot.

Voter-Nominated and Nonpartisan Offices

All voters, regardless of the party preference they disclosed upon registration, or refusal to disclose a party preference, may vote for any candidate for a voter-nominated or nonpartisan office. The party preference, if any, designated by a candidate for a voter-nominated office is selected by the candidate and is shown for the information of the voters only. It does not imply that the candidate is nominated or endorsed by the party or that the party approves of the candidate. The party preference, if any, of a candidate for a nonpartisan office does not appear on the ballot.

Party-Nominated Offices

Only voters who disclosed a preference upon registering to vote for the same party as the candidate seeking nomination of any party for the Presidency or election to a party committee may vote for that candidate at the primary election, unless the party has adopted a rule to permit non-party voters to vote in its primary elections.

CITY ATTORNEY'S IMPARTIAL ANALYSIS OF MEASURE GG

Measure GG was placed on the ballot by the Monterey Park City Council. This Measure would raise revenue for general city purposes by authorizing a ¼ cent sales tax within Monterey Park. This tax would be paid in addition to current sales taxes. California law authorizes the City Council to impose this sales tax, provided the tax is approved by a majority of the voters.

California sales taxes are comprised of three different components: (a) a state tax; (b) a county tax; and (c) a tax that may be imposed by a "district." A "district" includes cities, counties, and other public entities. Currently, the combined state and county sales tax equals 7.25%. The maximum rate for all sales taxes cannot exceed 10.25%.

The City of Monterey Park currently collects a 2% sales tax that it may use for general city operations and services; the overall sales tax rate in the City is 9.5% (this includes sales tax imposed by other districts). Consequently, a district (including the City) could impose up to an additional .75% (or ¾ cent) tax before reaching the maximum tax rate.

Measure GG proposes to approve a .75% (or ¾ cent) sales tax for the City to reach the maximum tax rate of 10.25%. If the sales tax proposed by Measure GG is collected, all revenue would benefit the City of Monterey Park. Public documents project that this tax would result in approximately \$4,000,000 of additional annual revenue. There is no sunset to this general tax.

All the taxes implemented by Measure GG may be suspended or reduced by City Council action. Any other increase of the tax would first require a change in California law and then additional voter approval.

Measure GG would impose a "general tax." Therefore, all tax revenue would be available for use by the City to pay for general City operations and services. The City would not be legally bound in any way to use the tax monies for any special purpose or for any particular facilities or programs. Since this ballot measure proposes a "general tax" rather than a "special tax," it requires approval by a simple majority of the City's voters.

A "yes" vote on Measure GG favors the Measure. A "no" vote on Measure GG opposes the Measure.

PROPOSED ORDINANCE OF MEASURE GG

PROPOSITION AUTHORIZING IMPOSITION OF A GENERAL THREE-QUARTER CENT TRANSACTIONS AND USE TAX (SALES TAX) TO FUND GENERAL MUNICIPAL SERVICES TO BE ADMINISTERED BY THE STATE BOARD OF EQUALIZATION.

The people of the city of Monterey Park do ordain as follows:

SECTION 1: A new Chapter 3.30 is added to Title 3 of the Monterey Park Municipal Code ("MPMC") to read as follows:

Chapter 3.30. Transactions and Use Tax

3.30.010. TITLE. This Chapter is entitled the "Monterey Park Transactions and Use Tax." The term "City," as used within this Chapter, is the City of Monterey Park. This Chapter is applicable in the incorporated territory of the City.

3.30.020. OPERATIVE DATE. "Operative Date" means the first day of the first calendar quarter commencing more than 110 days after the adoption of this Chapter, the date of such adoption being as set forth below.

3.30.030. PURPOSE. This Chapter is adopted to achieve the following, among other purposes, and directs that its provisions be interpreted in order to accomplish those purposes:

A. To impose a retail transactions and use tax in accordance with the provisions of Part 1.6 (commencing with Section 7251) of Division 2 of the Revenue and Taxation Code and Section 7285.9 of Part 1.7 of Division 2 of the Revenue and Taxation Code which authorizes the City to adopt this Chapter which becomes operative if a majority of the electors voting on the ballot measure approving the Chapter vote to approve the imposition of the tax at an election called for that purpose.

B. To adopt retail transactions and use tax regulations that incorporates provisions identical to those of the Sales and Use Tax Law of the State of California insofar as those provisions are not inconsistent with the requirements and limitations contained in Part 1.6 of Division 2 of the Revenue and Taxation Code.

C. To adopt retail transactions and use tax regulations that imposes a tax and provides a measure therefore that can be administered and collected by the State Board of Equalization in a manner that adapts itself as fully as practicable to, and requires the least possible deviation

from, the existing statutory and administrative procedures followed by the State Board of Equalization in administering and collecting the California State Sales and Use Taxes.

D. To adopt a retail transactions and use tax ordinance that can be administered in a manner that will be, to the greatest degree possible, consistent with the provisions of Part 1.6 of Division 2 of the Revenue and Taxation Code, minimize the cost of collecting the transactions and use taxes, and at the same time, minimize the burden of record keeping upon persons subject to taxation under the provisions of this ordinance.

3.30.040. EXPENDITURES.

A. The Monterey Park Transactions and Use Tax is imposed to provide funds for the City to pay for general municipal services.

B. The City Council may provide for collection of the general tax in the same manner and subject to the same penalties as, or with, other charges and taxes fixed and collected by the City, or by the County of Los Angeles on behalf of the City. If the general tax is collected by the County on behalf of the City, the County may deduct its reasonable costs incurred in such service.

C. The City's cost of enforcing and administering this chapter, including refunds, can be paid from the general tax revenue.

3.30.050. CONTRACT WITH STATE. Before the operative date, the City must contract with the State Board of Equalization to perform all functions incident to the administration and operation of this Chapter; provided, that if the City has not contracted with the State Board of Equalization before the operative date, it must nevertheless so contract and in such a case the operative date is the first day of the first calendar quarter following the execution of such a contract.

3.30.060. TRANSACTIONS TAX RATE. For the privilege of selling tangible personal property at retail, a transaction tax is hereby imposed upon all retailers in the incorporated territory of the City at the rate of 0.75% of the gross receipts of any retailer from the sale of all tangible personal property sold at retail in said territory on and after the operative date of this ordinance.

3.30.070. PLACE OF SALE. For the purposes of this Chapter, all retail sales are consummated at the place of business of the retailer unless the tangible personal property sold is delivered by the retailer or his agent to an out-of-state destination or to a common carrier for delivery to an out-of-state destination. The gross receipts from such sales

include delivery charges, when such charges are subject to the state sales and use tax, regardless of the place to which delivery is made. In the event a retailer has no permanent place of business in the State or has more than one place of business, the place or places at which the retail sales are consummated is determined under rules and regulations to be prescribed and adopted by the State Board of Equalization.

3.30.080. USE TAX RATE. A use tax is imposed on the storage, use or other consumption in the City of tangible personal property purchased from any retailer on and after the operative date of this ordinance for storage, use or other consumption in said territory at the rate of 0.75% of the sales price of the property. The sales price includes delivery charges when such charges are subject to state sales or use tax regardless of the place to which delivery is made.

3.30.090. ADOPTION OF PROVISIONS OF STATE LAW. Except as otherwise provided in this ordinance and except insofar as they are inconsistent with the provisions of Part 1.6 of Division 2 of the Revenue and Taxation Code, all of the provisions of Part 1 (commencing with Section 6001) of Division 2 of the Revenue and Taxation Code are adopted and made a part of this Chapter as though fully set forth.

3.30.100. LIMITATIONS ON ADOPTION OF STATE LAW AND COLLECTION OF USE TAXES. In adopting the provisions of Part 1 of Division 2 of the Revenue and Taxation Code:

A. Wherever the State of California is named or referred to as the taxing agency, the name of this City will be substituted. However, the substitution is not made when:

1. The word "State" is used as a part of the title of the State Controller, State Treasurer, State Board of Control, State Board of Equalization, State Treasury, or the Constitution of the State of California;

2. The result of that substitution would require action to be taken by or against this City or any agency, officer, or employee thereof rather than by or against the State Board of Equalization, in performing the functions incident to the administration or operation of this Chapter.

3. In those sections, including, but not necessarily limited to sections referring to the exterior boundaries of the State of California, where the result of the substitution would be to:

a. Provide an exemption from this tax with respect to certain sales, storage, use or other consumption of tangible personal property which would not otherwise be exempt from this tax while such sales, storage, use or other

consumption remain subject to tax by the State under the provisions of Part 1 of Division 2 of the Revenue and Taxation Code, or

b. Impose this tax with respect to certain sales, storage, use or other consumption of tangible personal property which would not be subject to tax by the state under the said provision of that code.

4. In Sections 6701, 6702 (except in the last sentence thereof), 6711, 6715, 6737, 6797 or 6828 of the Revenue and Taxation Code.

B. The word "City" is substituted for the word "State" in the phrase "retailer engaged in business in this State" in Section 6203 and in the definition of that phrase in Section 6203 of the Revenue and Taxation Code.

3.30.110. PERMIT NOT REQUIRED. If a seller's permit has been issued to a retailer under Section 6067 of the Revenue and Taxation Code, an additional transactor's permit is not required by this Chapter.

3.30.120. EXEMPTIONS AND EXCLUSIONS.

A. There is excluded from the measure of the transactions tax and the use tax the amount of any sales tax or use tax imposed by the State of California or by any city, city and county, or county pursuant to the Bradley-Burns Uniform Local Sales and Use Tax Law or the amount of any state-administered transactions or use tax.

B. There are exempted from the computation of the amount of transactions tax the gross receipts from:

1. Sales of tangible personal property, other than fuel or petroleum products, to operators of aircraft to be used or consumed principally outside the county in which the sale is made and directly and exclusively in the use of such aircraft as common carriers of persons or property under the authority of the laws of this State, the United States, or any foreign government.

2. Sales of property to be used outside the City which is shipped to a point outside the City, pursuant to the contract of sale, by delivery to such point by the retailer or his agent, or by delivery by the retailer to a carrier for shipment to a consignee at such point. For the purposes of this paragraph, delivery to a point outside the City is satisfied:

a. With respect to vehicles (other than commercial vehicles) subject to registration pursuant to Chapter 1 (commencing with Section 4000) of Division 3 of the Vehicle Code, aircraft licensed in compliance with Section 21411 of the Public Utilities Code, and undocumented vessels registered under Division 3.5 (commencing with Section 9840) of the Vehicle

Code by registration to an out-of-City address and by a declaration under penalty of perjury, signed by the buyer, stating that such address is, in fact, his or her principal place of residence; and

b. With respect to commercial vehicles, by registration to a place of business out-of-City and declaration under penalty of perjury, signed by the buyer, that the vehicle will be operated from that address.

3. The sale of tangible personal property if the seller is obligated to furnish the property for a fixed price pursuant to a contract entered into before the operative date of this ordinance.

4. A lease of tangible personal property which is a continuing sale of such property, for any period of time for which the lessor is obligated to lease the property for an amount fixed by the lease before the operative date of this ordinance.

5. For the purposes of subparagraphs (3) and (4) of this section, the sale or lease of tangible personal property is deemed not to be obligated pursuant to a contract or lease for any period of time for which any party to the contract or lease has the unconditional right to terminate the contract or lease upon notice, whether or not such right is exercised.

C. There are exempted from the use tax imposed by this Chapter, the storage, use or other consumption in this City of tangible personal property:

1. The gross receipts from the sale of which have been subject to a transactions tax under any state-administered transactions and use tax ordinance.

2. Other than fuel or petroleum products purchased by operators of aircraft and used or consumed by such operators directly and exclusively in the use of such aircraft as common carriers of persons or property for hire or compensation under a certificate of public convenience and necessity issued pursuant to the laws of this State, the United States, or any foreign government. This exemption is in addition to the exemptions provided in Sections 6366 and 6366.1 of the Revenue and Taxation Code of the State of California.

3. If the purchaser is obligated to purchase the property for a fixed price pursuant to a contract entered into before the operative date of this ordinance.

4. If the possession of, or the exercise of any right or power over, the tangible personal property arises under a lease which is a continuing purchase of such property for any

period of time for which the lessee is obligated to lease the property for an amount fixed by a lease before the operative date of this ordinance.

5. For the purposes of subparagraphs (3) and (4) of this section, storage, use, or other consumption, or possession of, or exercise of any right or power over, tangible personal property is deemed not to be obligated pursuant to a contract or lease for any period of time for which any party to the contract or lease has the unconditional right to terminate the contract or lease upon notice, whether or not such right is exercised.

6. Except as provided in subparagraph (7), a retailer engaged in business in the City is not required to collect use tax from the purchaser of tangible personal property, unless the retailer ships or delivers the property into the City or participates within the City in making the sale of the property, including, without limitation, soliciting or receiving the order, either directly or indirectly, at a place of business of the retailer in the City or through any representative, agent, canvasser, solicitor, subsidiary, or person in the City under the authority of the retailer.

7. "A retailer engaged in business in the City" also includes any retailer of any of the following: vehicles subject to registration pursuant to Chapter 1 (commencing with Section 4000) of Division 3 of the Vehicle Code, aircraft licensed in compliance with Section 21411 of the Public Utilities Code, or undocumented vessels registered under Division 3.5 (commencing with Section 9840) of the Vehicle Code. That retailer is required to collect use tax from any purchaser who registers or licenses the vehicle, vessel, or aircraft at an address in the City.

D. Any person subject to use tax under this Chapter may credit against that tax any transactions tax or reimbursement for transactions tax paid to a district imposing, or retailer liable for a transactions tax pursuant to Part 1.6 of Division 2 of the Revenue and Taxation Code with respect to the sale to the person of the property the storage, use or other consumption of which is subject to the use tax.

3.30.130. AMENDMENTS. All amendments subsequent to the effective date of this Chapter to Part 1 of Division 2 of the Revenue and Taxation Code relating to sales and use taxes and which are not inconsistent with Part 1.6 and Part 1.7 of Division 2 of the Revenue and Taxation Code, and all amendments to Part 1.6 and Part 1.7 of Division 2 of the Revenue and Taxation Code, automatically become a part

of this Chapter, provided however, that no such amendment operates so as to affect the rate of tax imposed by this ordinance.

3.30.140. ENJOINING COLLECTION FORBIDDEN. No injunction or writ of mandate or other legal or equitable process may issue in any suit, action or proceeding in any court against the State or the City, or against any officer of the State or the City, to prevent or enjoin the collection under this ordinance, or Part 1.6 of Division 2 of the Revenue and Taxation Code, of any tax or any amount of tax required to be collected.

3.30.150. SUSPENSION OR REDUCTION. Nothing in this Chapter requires the City Council to collect a tax; the city council may suspend or reduce tax rates imposed by this chapter by resolution after a public hearing.

3.30.160. CITY COUNCIL AUTHORITY TO AMEND. Except for amendments that would increase the tax rate, impose the tax on transactions and uses not previously subject to the tax, or be inconsistent with the purposes of this chapter, the City Council may exercise all applicable powers set forth in the Government Code including, without limitation, amending this chapter by ordinance upon three affirmative votes by its members. It may, in addition, adopt by ordinance or resolution such additional regulations that may be necessary to implement the purposes of this chapter."

SECTION 2: Environmental Analysis. This Proposition is exempt from review under the California Environmental Quality Act (California Public Resources Code §§ 2100, et seq., "CEQA") and CEQA regulations (14 California Code of Regulations §§ 15000, et seq.) because it establishes rules and procedures to implement government funding mechanisms; does not involve any commitment to a specific project which could result in a potentially significant physical impact on the environment; and constitutes an organizational or administrative activity that will not result in direct or indirect physical changes in the environment. Accordingly, this Resolution does not constitute a "project" that requires environmental review (see specifically 14 CCR § 15378(b)(4-5)).

SECTION 3: Continuity. Repeal of any provision of the Monterey Park Municipal Code does not affect any penalty, forfeiture, or liability incurred before, or preclude prosecution and imposition of penalties for any violation occurring before this Ordinance's effective date. Any such repealed part will remain in full force and effect for sustaining action or prosecuting violations occurring before the effective date of this Ordinance.

SECTION 4: Severability. If any part of this Ordinance or its application is deemed invalid by a court of competent jurisdiction, the city council intends that such invalidity will not affect the effectiveness of the remaining provisions or applications and, to this end, the provisions of this Ordinance are severable.

SECTION 5: Validity of Previous Code Sections. If this the entire Ordinance or its application is deemed invalid by a court of competent jurisdiction, any repeal of the MPMC or other regulation by this Ordinance will be rendered void and cause such MPMC provision or other regulation to remain in full force and effect for all purposes.

SECTION 6: Voter Approval. This Proposition will enact and impose a general tax. Accordingly, it will be submitted to a general election on March 3, 2020 for voter approval. If **A MAJORITY** of voters vote in favor of this Proposition, it will become valid and binding on the date that the City Council certifies the election results. Should the provisions of Government Code §§ 53720 et seq. or California Constitution Article XIII C be repealed or amended, or interpreted by the courts so that voter approval is not required for enacting this Proposition, then this Proposition will take effect as provided for all other City ordinances and may be amended in the same manner as all other City ordinances.

SECTION 7: Miscellaneous.

A. This Proposition must be interpreted so as to be consistent with all federal and state laws, rules, and regulations. If any section, sub-section, sentence, clause, phrase, part, or portion of this Proposition is held to be invalid or unconstitutional by a final judgment of a court of competent jurisdiction, such decision does not affect the validity of the remaining portions of this Proposition. The voters declare that this Proposition, and each section, sub-section, sentence, clause, phrase, part, or portion thereof, would have been adopted or passed irrespective of the fact that any one or more sections, sub-sections, sentences, clauses, phrases, part, or portion is found to be invalid. If any provision of this Proposition is held invalid as applied to any person or circumstance, such invalidity does not affect any application of this Proposition that can be given effect without the invalid application.

B. If any portion of this Proposition is held by a court of competent jurisdiction to be invalid, we the People indicate our strong desire that: (i) the City Council use its best efforts to sustain and reenact that portion, and (ii) the City Council implement this Proposition by taking all steps possible to cure any inadequacies or deficiencies identified by the court

in a manner consistent with the express and implied intent of this Proposition, and then adopting or reenacting such portion as necessary or desirable to permit the planning and development of the Project.

C. This Proposition must be broadly construed in order to achieve the purposes stated in this Proposition. It is the intent of the voters that the provisions of this Proposition be interpreted or implemented by the City and others in a manner that facilitates the purposes set forth in this Proposition.

SECTION 8: The Mayor will sign this Proposition and the City Clerk will attest and certify to the passage and adoption of this Proposition if a majority of the voters voting in the City's general election on March 3, 2020 approve the proposition asking whether the voters approve this Proposition.

SECTION 9: Pursuant to Revenue and Taxation Code § 7265, this Proposition will become operative on the first day of the first calendar quarter commencing more than 110 days after the adoption of this Proposition.

CITY ATTORNEY'S IMPARTIAL ANALYSIS OF MEASURE HH

Measure HH is an advisory measure. It is not a tax and cannot legally affect how the City spends tax revenue. If enacted, Measure HH would state the voters' intent regarding how the City should spend new revenue generated by an increase in sales tax.

If enacted, Measure HH would advise the City that the voters intend that any new tax revenue be used for public projects including streets; sidewalks; traffic control signals; streetlights; equipment for public safety services; library equipment and collections; and park improvements. Measure HH would further advise that new sales tax revenue should not be utilized for miscellaneous costs including public employee salaries.

Measure HH also advises the City that new tax revenue should be used as additional funding for public projects. This means that new tax revenue should not be used to allow already budgeted money to be repurposed to pay for miscellaneous expenses including public employee salaries.

To be adopted, Measure HH must be approved by a simple majority of the voters in the City of Monterey Park.

A "yes" vote on Measure HH favors its enactment.

A "no" vote on Measure HH opposes its enactment.

PROPOSED ORDINANCE OF MEASURE HH

A PROPOSITION ADVISING THE CITY OF MONTEREY PARK REGARDING EXPENDITURE OF REVENUE RESULTING FROM A 3/4 SALES TAX INCREASE

This measure is NOT a tax. This proposition is a nonbinding advisory measure that states the City of Monterey Park's voters' intent that any new revenue received by the City of Monterey Park as a result of a 3/4 cent sales tax increase be spent, in addition to and not a substitution for other budgeted funds, on the public projects identified below.

- Alley reconstruction;
- Street resurfacing/rehabilitation;
- Sidewalk reconstruction for Americans with Disabilities Act Compliant;
- Traffic signal upgrades to alleviate congestion and improve traffic flow;
- Citywide street lighting, parkway and median maintenance;
- Safety equipment to enhance emergency services;
- Library collections, database, and replacement of public access computers;
- Thirteen Citywide parks rehabilitation projects including: Restroom rehabilitation and improvements to, among other things, complying with the American with Disabilities Act; Park playground equipment to comply with American with Disabilities Act; Irrigation system improvement; Park parking lot reconstruction; and Pavilion and picnic shelter rehabilitation.

Sales tax revenue should not be used by the City Council for general municipal purposes including, without limitation, ongoing public employee salaries. The City may, however, spend a reasonable amount of the sales tax revenue for administrative costs directly related to implementing the public projects listed above.

CITY ATTORNEY'S IMPARTIAL ANALYSIS OF MEASURE II

Measure II was placed on the ballot by the Monterey Park City Council. Measure II would adopt a new Land Use Element (the "LUE") for the Monterey Park General Plan (the "GP").

Under California law, the City's GP must include seven elements: the LUE; Circulation; Housing; Conservation; Open space; Noise; and Safety. Overall, the GP – particularly the LUE – constitutes the City's "constitution" for economic, social, and land use development.

In Monterey Park, voter approval is required to adopt or amend the LUE. Voters last considered the LUE in 2001. If approved by voters, the proposed LUE would regulate land uses until 2040.

Generally, the proposed LUE would make some adjustments to land uses; building sizes; and building heights. Such changes would occur primarily in areas identified by the 2001 LUE including Downtown Monterey Park, East Garvey, Atlantic Boulevard, Mid Atlantic, South Atlantic, North Garfield, South Garfield, Monterey Pass Road, Corporate Center, and Saturn Park.

To ensure that the LUE is implemented, Measure II would authorize the City Council to adopt regulations by ordinance. Measure II would also authorize the City Council to amend the LUE and other regulations on its own authority in response to changes in California law.

A "yes" vote on Measure II favors the Measure. A "no" vote on Measure II opposes the Measure.

PROPOSED ORDINANCE OF MEASURE II

The People of the City of Monterey Park do ordain as follows:

SECTION 1: Title. This proposition is entitled the "Monterey Park 2040 Land Use and Urban Design Element Proposition."

SECTION 2: Adoption of Land Use Element of the General Plan. The Land Use Element of the Monterey Park General Plan approved by the City Council on December 5, 2019 (the "LUE") is adopted by this reference as if fully set forth. Because the LUE is voluminous (more than 100 pages), the full text of the measure may be accessed on the City's website at the following web site address: www.montereypark.ca.gov/MPKLUE.

SECTION 3: Implementation of this Proposition.

A. City Council Authority. Pursuant to Elections Code § 9217, the People authorize and direct the City Council to promptly take appropriate actions needed to implement this Proposition including, without limitation, adopting all zoning regulations needed to effectuate this Proposition by ordinance. Upon the effective date of this Proposition and notwithstanding any limitation on the City Council's authority set forth in this Proposition or the Monterey Park Municipal Code, all land use regulations adopted by the City Council that are consistent with this Proposition are retroactively ratified and validated by the People.

B. State Imposed Land Use Legislation. Pursuant to Elections Code § 9217, the People authorize and direct the City Council to undertake appropriate actions needed to implement state legislation affecting land use regulations by ordinance. Upon the effective date of this Proposition and notwithstanding any limitation on the City Council's authority set forth in this Proposition or the Monterey Park Municipal Code, all land use regulations needed to be adopted or amended in response to state legislation including, without limitation, the land use element and zoning regulations, may be adopted upon the City Council's own authority.

SECTION 4: Interpretation. This Proposition must be interpreted to be consistent with all federal and state laws, rules, and regulations. If any section, sub-section, sentence, clause, phrase, part, or portion of this Proposition is held to be invalid or unconstitutional by a final judgment of a court of competent jurisdiction, such decision does not affect the validity of the remaining portions of this Proposition. The People declare that this Proposition, and each section, sub-

section, sentence, clause, phrase, part, or portion thereof, would have been adopted or passed irrespective of the fact that any one or more sections, sub-sections, sentences, clauses, phrases, part, or portion is found to be invalid. If any provision of this Proposition is held invalid as applied to any person or circumstance, such invalidity does not affect any application of this Proposition that can be given effect without the invalid application.

SECTION 5: Repeal and Supersession. The People adopt this Proposition with the specific intent of superseding any contrary regulation, including those previously adopted by the People, or administrative policy and procedure. Consequently, all regulations that conflict with this Proposition are repealed or modified to reconcile them with this Proposition.

SECTION 6: Construction. This Proposition must be broadly construed in order to achieve the purposes stated in this Proposition. It is the People's intent that the provisions of this Proposition be interpreted or implemented by the City and others in a manner that facilitates the purposes set forth in this Proposition.

SECTION 7: Enforceability. Repeal of any provision of the MPMC does not affect any penalty, forfeiture, or liability incurred before, or preclude prosecution and imposition of penalties for any violation occurring before this Proposition's effective date. Any such repealed part will remain in full force and effect for sustaining action or prosecuting violations occurring before the effective date of this Proposition.

SECTION 8: Validity of Previous Code Sections. If this entire Proposition or its application is deemed invalid by a court of competent jurisdiction, any repeal or amendment of the LUE, MPMC, or other ordinance by this Proposition will be rendered void and cause such previous LUE, MPMC provision, or other the ordinance to remain in full force and effect for all purposes.

SECTION 9: Severability. If any portion of this Proposition is held by a court of competent jurisdiction to be invalid, the remainder of the Proposition and the application of such provision to other persons or circumstances will not be affected thereby. We the People indicate our strong desire that: (i) the City Council use its best efforts to sustain and reenact that portion, and (ii) the City Council implement this Proposition by taking all steps possible to cure any inadequacies or deficiencies identified by the court in a manner consistent with the express and implied intent of this Proposition, and then adopting or reenacting such portion as necessary or desirable to allow its implementation.

SECTION 10: Effective Date. This Proposition will be submitted to a general election on March 3, 2020 for voter approval. If a majority of voters vote in favor of this Proposition, it will become valid and binding 10 days after the date that the City Council certifies the election results in accordance with Elections Code § 9217. The Mayor will sign this Proposition and the City Clerk will attest and certify to the passage and adoption of this Proposition.

IMPARTIAL ANALYSIS OF MEASURE R

By Mary C. Wickham, County Counsel

Measure R is a citizens' initiative that qualified for placement on the ballot based on a sufficient number of registered voters signing a petition proposing this ballot measure. If approved by the voters, the measure would adopt an ordinance amending Title 3 of the Los Angeles County Code relating to the Sheriff Civilian Oversight Commission ("Commission").

California law currently requires the Board of Supervisors ("Board") to supervise the official conduct of all county officers and also gives the Board the power to create a commission and determine its powers. The Board created the Commission in the County Code giving it authority to review, analyze, and make recommendations to the Board and Sheriff's Department ("Sheriff") on Sheriff's operational policies and procedures, and to investigate systemic Sheriff-related issues or complaints through the Office of Inspector General ("OIG").

As of the date of this Impartial Analysis, the current law is the Commission does not have independent subpoena power to compel testimony of witnesses or production of documents. The power to subpoena records and witnesses rests with the Board or may be delegated by the Board. The Commission may receive records from the Sheriff and OIG, subject to applicable and confidentiality laws. This measure would amend the County Code to give the Commission independent subpoena power to obtain documents or witnesses pertinent to its investigations and oversight, and provides the Commission power to administer oaths. The Commission would not be bound to follow Agreements between the Sheriff and OIG for access to records.

As of the date of this Impartial Analysis, the current law is the Commission does not have the independent power to perform investigations, inquiries, audits or monitoring without using the OIG. This measure would amend the County Code to allow the Commission to use its own members or staff to undertake investigations, inquiries, audits, and monitoring in addition to using the OIG.

As of the date of this Impartial Analysis, the Commission does not have the authority to independently review and evaluate the OIG's handling and resolution of citizen and inmate complaints. This measure would also amend the

County Code to permit the Commission to review and evaluate the OIG's handling and resolution of citizen and inmate complaints.

This measure would require the Commission to research and draft a plan ("Plan") for reducing the County's jail population and providing alternatives to incarceration by conducting a Feasibility Study, together with a timeline for reinvestment of jail system costs into prevention and mental health treatment. The Feasibility Study would include the impacts of incarceration on the jail population; compare the costs and effectiveness of mental health treatment inside the jail with community-based drug treatment; identify needed infrastructure; and recommend staffing and funding solutions to the Board. The Board is not bound to take action on the proposed Plan.

The measure, if approved by the voters, may only be repealed by a subsequent vote of the electorate on an amendment of the Los Angeles County Code or County Charter, and the Board would not have independent authority to amend the duties and powers of the Commission.

The measure requires a majority vote.

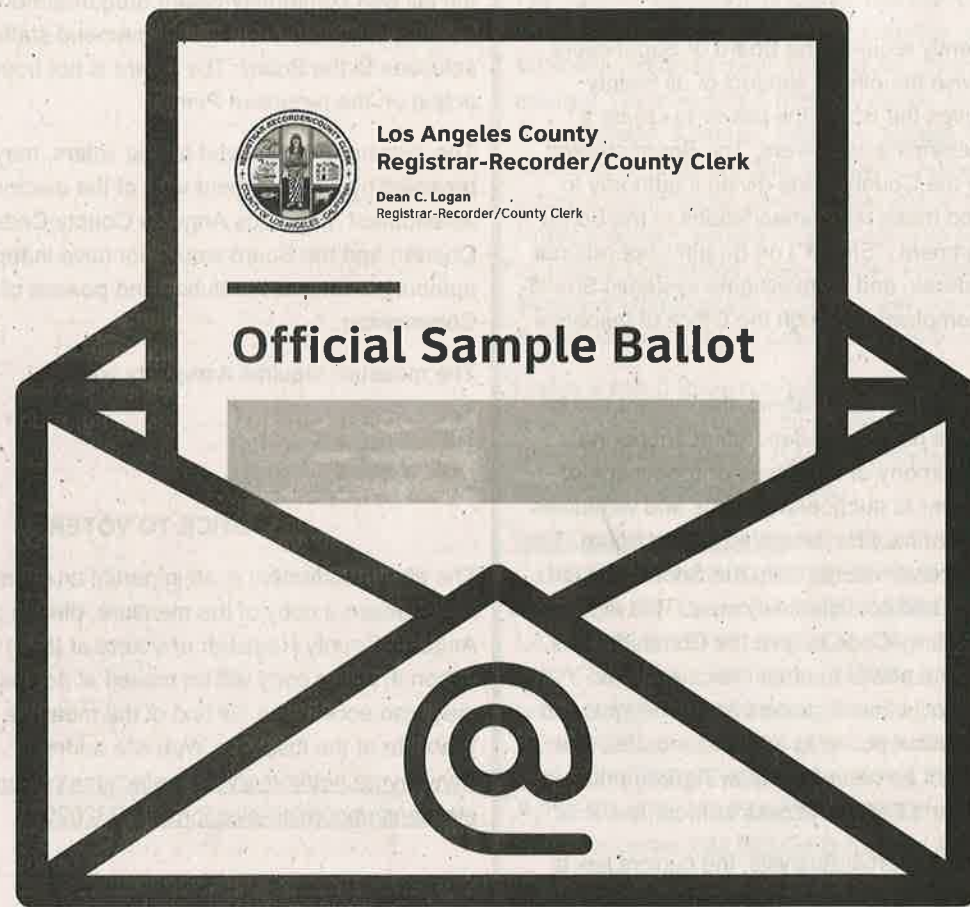

EARTHQUAKE

If you're like most people, after every California earthquake you tell yourself, "I'm going to get prepared for the next one."

Then you don't do a thing about it.

Well, now you can do something about it. Just by reading this page, doing what it says and saving it.

Many earthquake experts in Southern California recommend the following tips to minimize damage in the event of an earthquake.

1. Put together a kit of basic emergency supplies. Include a portable radio, extra batteries, a first aid kit and handbook, wrenches to turn off gas and water valves, and food, water and medication for every member of your family for at least one week.
2. Secure your hot water heater. If your hot water heater falls over during an earthquake, the gas line can rupture and create sparks which can lead to a fire or explosion.
3. Know where your gas, electric and water main shutoffs are and how to shut them off.
4. Secure your tall and heavy furniture. Bookcases, entertainment centers and china cabinets can easily fall over during an earthquake.
5. Put some extra nails in heavy objects that are off the floor such as shelves, mirrors and large picture frames.
6. Hunt for hazard areas in your home. Teach your children to stay away from windows, mirrors and tall furniture.
7. Search for safe place in your home. Show your children how to take cover under a table, desk, or against inside walls.
8. Have a plan to reunite your family after an earthquake. Travel may be difficult and phone lines may be down, so don't drive or call anyone unless it's a real emergency.
9. Check for injury or damage after the shaking stops.
10. Above all, do not panic.

Practicing earthquake drills with your entire family and being prepared with the above instructions will put you in a safer position during any ground motion.

Stop rumbling about how you're going to get ready for "the next one." Prepare for it today. The County of Los Angeles has an Earthquake Survival Program (ESP) with easy monthly preparedness steps.
