On Tuesday, March 14, 2023, the President of the United States, Joseph R. Biden, Jr., is planning to visit Monterey Park. The purpose of this letter is to inform you of temporary “No Parking” zones, street closures, and Barnes Park closure that will be in effect on **Tuesday, March 14, 2023 from 7 a.m. to 8 p.m.** There will be limited vehicular/pedestrian access and no parking allowed on the streets and park listed in this notice and in the attached map. Barricades will be installed to block vehicular access. **Please be advised that vehicles parked in the restricted areas will be towed.** If these street closures prevent you from entering or exiting your property during restricted hours, please park your vehicle on an unaffected street before the barricades are set up.
