



# Business Paramedic Ambulance Membership Program

Dear Business Owner:

The Monterey Park Fire Department provides emergency ambulance service to residents and businesses in Monterey Park. Monterey Park paramedics are highly trained in the use of advanced life support systems and are seasoned medical professionals whose specialty is saving lives. The cost associated with these services increases yearly, with the average cost of \$1,200 charged by private ambulance companies compared to the average cost of \$1,034 plus supplies and medications the City must bill non-subscribers for paramedic service.

As a business owner in Monterey Park, we welcome you to join the Paramedic Ambulance Membership Program to cover you and your permanent employees for the uninsured co-payments most insurance companies, Medicare and Medi-Cal require you to pay. Although your employees may have medical insurance, it has been our experience that many policies do not fully cover emergency medical services. Therefore for you or your employees who are not fully covered, the purchase of this subscription is a wonderful and thoughtful benefit.

Joining this program is voluntary and covers Monterey Park emergency paramedic and ambulance calls occurring at your business during your normal business hours.

*Voluntary Emergency Medical Subscription Program Agreement (Please read carefully & sign)*

I understand the subscription fee provides paramedic ambulance services for all permanent employees of my business for incidents occurring at my business, during normal business hours. I understand the subscription fee is non-refundable. I also understand the Monterey Park Fire Department reserves the right to bill any insurance that I or any of my employees may have for the normal fees associated with the emergency medical services provided, and that such payment when received by the City of Monterey Park will be accepted as payment in-full for the emergency medical services rendered. I agree to provide to the City of Monterey Park all information regarding insurance coverage for any party covered under the terms of this subscription agreement. I agree to immediately forward any payment received by myself, or any employee, for paramedic ambulance services provided hereunder, to the City of Monterey Park. I further authorize the release of medical information for the purpose of emergency medical service billing. I understand members must notify the Fire Department upon rendering of service to ensure coverage. I understand membership runs from **July 1 to June 30 of each year** and that this membership is non-transferable. Any violations of the terms of this agreement could result in the cancellation of this membership.
